

VRS Studio Policies Client Agreement

Thank you for taking the time to consider VRS Studio for your recording needs!

VRS Studios has been in business for over 15 years and has produced, mixed, mastered and arranged music for many Award Winning Clients and Labels Indie and Major.

Below are some Studio Policies that you must be aware of before moving forward.

It is understood by Client/Artist that you understand that VRS Studio is a fully operation private Recording Studio and Production facility. VRS Studios Produces music, arrangements, recordings, mixing and mastering for multiple artists and clients and you must acknowledge studio policies below in order to move forward. If this agreement is attached to an email, You must respond and agree via email that you have read and fully understand this agreement.

You understand by reading this that you accept all terms within and understand FULLY the way we record and run the business.

You understand that VRS Studio is NOT responsible for Archiving, Storing, and Backing up you work after the project completion date. All clients are responsible for bringing a hard drive, or DVD and obtaining their sessions, masters, multi tracks, mixes once the project has completed. It is YOUR responsibility to ask Andy or any Engineer here at VRS to provide you with your material and you must provide the hard drive, disks or device for your data to be backed up on. Any Clients, who have left their recording, materials at VRS for more than 15 days after completion at VRS Studios without communication with Andy or VRS Studios, understands that such material may be PERMANENTLY DELETED! You understand that in the event that this happens, VRS Studios is not responsible and HELD HARMLESS. _____ Initial.

PRODUCTION:

In the event that Andy Anderson or any contractor employed by him is arranging, producing, programming on any material with Artist/Client, a separate Production agreement will be necessary. _____ Initial.

SCHEDULING:

You understand it is your responsibility to call and arrange and schedule your studio time in advance, 48 hours to 72 hours is preferred. VRS Studios will make any and all efforts to schedule your studio time at the time your request. It is not the responsibility of VSR Studios to schedule your studio time with less than 48 hours notice and VRS Studios is not responsible for any unusual deadlines that may occur on your behalf for alternative mixes, masters, TV Mixes, re arrangements in any manner. All Studio time must be scheduled in a respectful manner. If YOU foresee that you are going to need an alternative mix, version, or master with sudden deadlines, you must call and communicate to see if VRS Studios can schedule such time. In the event VRS Studios cannot schedule your time to meet your needs, VRS Studios is held harmless for consequences you may encounter. VRS Studios has the right to refuse recording you for, no shows, or cancellations for less than 48 hours notice. VRS Studios can refuse service for any reason to you and in the event that VRS Studios ceases to record you, VRS Studios will deliver any and all material to you that you own once studio time has been paid in full. In the event that Andy Anderson has co produced, arranged, any material on your music, a production agreement must be reached and signed off on before releasing your work.

PAYMENTS:

You understand that VRS Studios basic Studio Rate is 50\$ per hour. Rates may vary depending on the type of work being done. Music Production rates can vary and need to be discussed in detail and agreed upon before commencing recording and production. All payments are DUE AT THE END OF EACH STUDIO SESSION. In the event that you and Andy Anderson come to an agreement that you will accrue Studio hours and time and pay later, you understand that no more than one week shall pass before catching up on studio time. Until then, VRS Studios and Andy Anderson retain the rights to hold any music, mixes and arrangements from being delivered to anyone and you may incur late fees of 50\$ per week. In the Event you do not catch up payments, VRS Studios has the right to DELETE your work and is held harmless. In the event that any payments bounce, or are return to the bank, VRS Studios retains the right to freeze recording, Production until such errors are fixed. If a Deposit has been made to schedule a studio session and client/customer does not show up and or cancels with less than 24 hours notice without communication via call or text, VRS Studios retains the right to keep the deposit and can refuse to schedule client for further sessions.

You understand that all payments are final upon receipt.

MUSIC DELIVERY METHODS:

VRS Studios will deliver your music the way you want. It is your responsibility to ask Andy for any Alternative Mixes you may need at the conclusion of your project. In the even that you DO NOT ask and have not obtained any alternative mixes, You understand that additional Studio Time may need to be booked to obtain such mixes and that the Equipment used to obtain and recall your final mix may need to be utilized in order to get your mix reference back. VRS Studios can deliver, MP3, WAV File, AIFF Files and other media formats and you must discuss with Andy Anderson which ones you need. Uploading your sessions Via the Internet can be done, however takes time and you may be billed for it. Any Alternative Mixes that may be requested such as Stem mixes, Soundtracks etc. will be billed as additional studio time. TECHNICAL DIFFICULTIES: We are a Recording Studio with Many Thousands of Dollars worth of High End Pro Audio Equipment and it would be a wonderful world of all of that worked 100% of the time. But on occasion, technical difficulties may arise. VRS Studios Strives to provide you with the best recording experience and will make any and all efforts to do so. In any event that Technical Difficulties arise during your recording, you will NOT be billed for down time. VRS Studios will make every effort to provide you with any and all necessary additional hours needed to make up your time we will take care of you!

STUDIO EDICATE:

Please understand, that VRS Studios is a private professional Studio. We do not have the facilities for large groups of people in a session that do not belong there. Please be respectful of our space and time and please do not show up to session with UN needed people. If the people you are bringing are necessary to record such as choirs, large crowd vocals, backgrounds please try to arrange and notify Andy Anderson ahead of time so we can prepare and make the most of your studio time experience. Any large Groups showing up to sessions that are not schedule are required to leave immediately. We take your music seriously and we encourage you to do the same.

SONGWRITING and PRODUCTION:

VRS Studio is also a Songwriting and Production Studio. We have over 15 years of song writing with well knows producers and labels. In the event you are involved in a co production, Production, Songwriting Session, You understand that you must comply along with the additional Production Agreement that you have been presented. Please ask Andy Anderson about the Production Agreement. You understand that any and all musical compositions, arrangement that are performed by Andy Anderson shall from it's inception be split with artist and a % of the property of the writing performed by Andy Anderson will be split proportionality. All writers will respectfully own their appropriate portions of any songs they write and all will agree to sign Publishing Split Sheets when requested from any and all writers.

All Publishing Split Sheet shall be agreed upon in a separate document and signed by all parties. If you do not sign a music production agreement, it is understood that Andy Anderson or VRS Studio is not being hired as producer for your music and you will need to produce your own music or hire and bring in your own producer, programmer, and arranger.
